#### 1. GENERAL INFORMATION AND CONTRACT FORMATION

- 1.1 These General Terms and Conditions (hereinafter referred to as "GTC") define the terms of service between Janity Tibor EV (hereinafter: "Contractor") and the client (hereinafter: "Client"). By entering into any agreement or confirming any quote or proposal issued by the Contractor, the Client acknowledges and accepts the provisions set forth in this GTC.
- 1.2 The contract is deemed valid upon written acceptance by the Client of an offer issued by the Contractor, including via email, electronic signature, or other verifiable digital means.
- 1.3 The Contractor reserves the right to reject any order or service request that lacks sufficient detail, violates legal or ethical standards, or cannot be fulfilled due to technical or logistical limitations.

## 2. SCOPE OF SERVICES

- 2.1 The Contractor provides full-service **event production**, including (but not limited to):
  - Concept planning and creative direction
  - Vendor coordination and on-site management
  - Stage design, lighting, audio-visual support
  - Scheduling, rehearsal, and show-calling
  - Talent coordination and artist management
- 2.2 Any additional services not listed in the original agreement are subject to separate negotiation and billing.

### 3. CLIENT OBLIGATIONS

- 3.1 The Client shall provide all necessary information, access, and resources to enable the Contractor to deliver the services on time and at the expected standard.
- 3.2 The Client acknowledges that delays caused by insufficient input, late communication, or last-minute changes may result in additional costs or compromises in quality.

#### 4. SERVICE CONDITIONS AND COMMUNICATION

- 4.1 Upon agreement and/or receipt of down payment (if applicable), the Contractor shall confirm the service schedule and begin preparations as outlined in the scope of services.
- 4.2 All communications must be in writing (email is sufficient) to ensure traceability and clarity of expectations.

#### 5. PAYMENT TERMS

- 5.1 All prices are quoted **net**, VAT will be added in accordance with the applicable tax laws:
  - Hungary-based companies/individuals: 27% VAT
  - EU companies with valid VAT number: 0% VAT
  - EU individuals: 27% VAT
  - Non-EU companies and individuals: 0% VAT
- 5.2 Payment schedule (unless otherwise agreed in writing):
  - 50% deposit due upon contract signature
  - 50% due within 5 days after event delivery
- 5.3 Accepted payment methods: bank transfer to the Contractor's account: LT823250061708046952

### 6. CANCELLATION POLICY

- 6.1 If the Client cancels the event:
  - More than 30 days before event: 25% of total fee payable
  - 15–30 days before event: 50% of total fee payable
  - Less than 15 days: 100% of total fee payable
- 6.2 Cancellation must be made in writing and confirmed by the Contractor.

### 7. LIABILITY AND INSURANCE

- 7.1 The Contractor shall take all reasonable measures to ensure high-quality event execution but shall not be liable for:
  - External force majeure events (e.g., weather, strike, pandemic-related restrictions)
  - Delays or damages caused by third-party vendors not contracted by the Contractor
  - Equipment failures or artist no-shows not due to the Contractor's direct fault
- 7.2 The Client is encouraged to secure appropriate insurance (e.g., event cancellation, liability, etc.) for high-value or public events.

### 8. INTELLECTUAL PROPERTY & PROMOTION

- 8.1 Unless otherwise agreed, the Contractor reserves the right to document the event and use anonymized visual/audio content for promotional purposes on websites and social media platforms.
- 8.2 The Contractor agrees not to use any content that may infringe on the Client's privacy or brand image without explicit permission.

## 9. DATA PROTECTION

- 9.1 The Contractor will process personal data provided by the Client in accordance with Hungarian and EU data protection regulations (GDPR).
- 9.2 Client data will only be used for contract performance and lawful business operations.

# 10. FORCE MAJEURE

In case of unavoidable circumstances (e.g., war, natural disaster, pandemic lockdowns), either party may withdraw or request postponement without penalty. In such cases, the parties shall agree on fair compensation for completed work.

## 11. TERMINATION

- 11.1 The Contractor reserves the right to terminate the contract with immediate effect if:
  - The Client fails to pay agreed fees
  - The Client behaves in a way that endangers the Contractor's personnel or reputation
  - Legal proceedings are initiated against the Client that impact project execution

### 12. FINAL PROVISIONS

- 12.1 Any matters not regulated in this GTC shall be governed by the Hungarian Civil Code.
- 12.2 In the event of legal disputes, the Parties shall first attempt to resolve the issue amicably. Failing that, jurisdiction is granted to the competent courts of **Budapest**, **Hungary**.
