

Privacy Policy

1. DATA CONTROLLER

This privacy notice is intended to clearly and concisely inform individuals about how their personal data is processed in compliance with the General Data Protection Regulation (EU Regulation 2016/679 – “GDPR”) and Hungarian Act CXII of 2011 on the Right of Informational Self-Determination and on Freedom of Information ("Privacy Act").

The data controller undertakes to process personal data in accordance with the prevailing EU and Hungarian legislation and reserves the right to amend this policy, publishing any changes accordingly.

2. SCOPE OF THE PROCESSED DATA

Personal data is processed only with the voluntary consent of the data subject or when necessary for contract performance or legal compliance.

Categories of processed data:

- Full name
- Phone number
- Email address
- Billing address (street, postal code, city, country)
- Delivery address (if different)
- Tax number (if provided for invoicing)
- Content of customer messages

Data retention:

- Invoicing data is stored for 8 years (Act C of 2000 on Accounting).

- All other personal data is stored for 1 year following the last customer interaction unless a legal obligation requires otherwise.

3. DATA PROCESSORS

The data controller may transfer personal data to third-party service providers bound by confidentiality agreements and only to the extent necessary to perform their contractual duties.

3.1. Payment provider

4. INFORMATION PROVIDED TO DATA SUBJECTS

5. PERSONAL DATA PROCESSING DETAILS

5.1. Website Visitors

The system may automatically record the user's IP address, time of visit, and accessed pages.

- Legal basis: user consent
- Retention: up to 1 month
- Purpose: statistics and system maintenance

Cookies may be placed for analytical and marketing purposes. Users may disable or delete cookies through their browser settings.

5.2. Contact Forms and Emails

- Scope: full name, email address, billing details, message content
- Legal basis: consent or contract
- Retention: 30 days if no contract is made; 8 years if related to invoicing

5.3. Other processing

In cases not listed above, explicit information and consent will be sought before data processing.

6. DATA SECURITY AND STORAGE

The website is hosted by:

The data controller uses appropriate technical and organizational measures to ensure:

- Confidentiality (access only by authorized persons)
- Integrity (accuracy and consistency of data)
- Availability (data is accessible to authorized users when needed)

Electronic communications over the internet may involve risks; the data controller takes necessary precautions to minimize these risks.

7. DATA TRANSFER

Personal data is only transferred to external partners to the extent required to fulfill customer orders or contractual obligations.

8. RIGHTS AND REMEDIES

8.1. Right to Information

You may request information on the data we hold and how it is processed. The response is free of charge once per year and provided within 30 days.

8.2. Right to Erasure ("Right to be Forgotten")

You may request deletion of your personal data under the conditions set by GDPR. Legal retention obligations may override this right.

8.3. Right to Object

You may object to data processing if it is based on legitimate interests or used for direct marketing purposes. The objection will be assessed within 15 days.
